**Sub: Request to place demand against Grant to PRIs**


With reference to the aforesaid cited subject, this is to inform you that the demands against grant to PRIs have been submitted by some of the divisions and a part of the fund with respect to the total demand has already been released. A status report regarding requisitions made by such divisions and fund allotment details viz amount, respective DDO etc. are furnished in Annexure-I, as enclosed.

In this regard this is further to state that the remaining divisions who are yet to submit any requisition are requested to place their demands under the HOA Grants to the PRIs.

In this context a google spreadsheet, named "Requirement of fund under GRANTS-to-PRI" is shared under Google link within PHED Applications in the departmental website. In the said spreadsheet, the divisions are requested to place their requisitions, in respective tabs against different commissioned water supply schemes maintained by ZP or GPs to square off the pending liabilities.

This is further to mention that Grants to PRIs against fresh requisitions will henceforth be placed to Zilla Parishad only even if this scheme is maintaining by the VWSC. Zilla Parishad will further sub-allot the fund to the respective VWSCs. Necessary information regarding name of associated VWSCs, account no. etc. as required are to be furnished in the spreadsheet. For schemes maintained by ZP, the fund will be utilized by themselves.

The UCs, against the allotted fund for all schemes will have to be provided by ZPs henceforth.
